SWCD Chapter Gets Heart Healthy Advice

Presented by Dr. Kim Novak and Michelle Sutton, St. John's Prairie Heart

Have you heard the latest statistics on women and heart disease? Neither had most of us until our most recent meeting in Springfield. Our guests that day were Dr. Kim Novak and Michelle Sutton of St. John's Prairie Heart Institute.

Dr. Novak began by saying that while heart disease is more commonly known to affect men, actually one in two women die from some form of heart disease. She stated, however, that she usually sees effects of the disease about ten years later in women than in men. Dr. Novak also stated that while symptoms may be different between the sexes, the majority of all patients complain of some form of chest discomfort, be it heaviness, tightness, or just overall discomfort.

Dr. Novak went on to explain many of the risk factors for heart disease and how to reduce the risks for those who are more apt to develop problems. Some of the biggest risk factors such as smoking, high blood pressure, high cholesterol and blood sugar issues can be corrected and managed when caught early enough.

The most damaging of these risks is smoking. It is as addictive as cocaine and amphetamines. Dr. Novak stated that between 22 and 24% of all adults admit to smoking cigarettes. She stated that by kicking the habit a smoker can add up to 1 1/2 years to his or her lifetime.

Diabetes also poses a threat to heart health. Dr. Novak stated there are between 8 and 10 million people in the United States diagnosed with a form of diabetes. She also stated it is believed there are another 8 to 10 million who are not yet diagnosed. She recommends aggressive control of blood sugars in diabetics is necessary to help avoid future heart health issues.

Another factor to be aware of is good and bad cholesterol counts. Dr. Novak recommends bad cholesterol or LDL should be less than 100 and total of all cholesterols be less than 200. She stated, however, that much of one's cholesterol count is dictated by genetics. She recommends patients learn their cholesterol count at age 20 and check it every five years after that.

The final statistic every person should know is their blood pressure. Dr. Novak recommends a goal of 120/80. High blood pressure puts added stress on the heart and long term effects of it can be devastating.

Dr. Novak ended by answering several questions from the group. Her presentation was very interesting and informative. We all received some good advice and hopefully we can make those strides toward leading more heart-healthy lives.


